ADDITIONAL INFORMATION

On 11/17/2003, at about 1240 hours, I was stationary at milepost 203 on I-40. I was monitoring traffic and observed a red sedan approaching my position traveling eastbound that was traveling 72 in the posted 65mph zone. I tracked the vehicle using my doppler radar in stationary mode and the vehicle slowed to 71 as it passed me. I decided to stop the sedan and pulled out from my position in the median.

I caught up to the vehicle at milepost 205 and activated my emergency lights. The sedan stopped on the eastbound emergency lane. I contacted the driver and gathered I.D. from the driver and all passenger's. I indicated to the driver, identified as Steve Gartin, why that I had stopped him and asked him to come back to my patrol vehicle. At my vehicle I gathered basic trip information from Gartin.

I also conducted license/wants checks on the other passengers. The rear seat passenger was found to have a felony warrant out for his arrest in Colorado. At 1250 hours, I arrested the rear seat passenger, Jose Jimenez, for the warrant and placed him into the rear seat of my patrol vehicle.

After placing Jimenez into my vehicle I conducted a search, incident to arrest, of the passenger compartment of the vehicle. I located approximately 1/4oz of marijuana underneath the front of the driver's seat and approximately 1/8oz in the center console. I also found a pipe and rolling papers in the center console of the vehicle.

The contraband items were seized as evidence and sent to the DPS crime lab for testing. Gartin was questioned about the items in depth but denied any knowledge. Gartin was cited and released for possession of marijuana and drug paraphernalia due to his proximity to the items and that he is the registered owner of the vehicle.

Jimenez was released after Colorado authorities declared that they would not extradite him from Arizona.
